

APPOINTMENTS – needing action for Sept Cycle

- 1) Ethics Board – Rev Trinetta McCray accepted offer of appointment. Her appointment letter was distributed downstairs a couple of weeks ago. (Ethics Board appointments require 30 day notice to all board members)
- 2) Public Art Committee – I think we have found two ideal candidates for appointment: Melissa McDonald (Rob’s wife), and Lynda Snodgrass of Wauwatosa. Both have enough Art background to pass confirmation and most important won’t agree to anything that could cause controversy for the Exec.
- 3) Milwaukee Art Museum – Have appointment letters ready to go downstairs for Supvs Rice & Broderick
- 4) Milwaukee Symphony Orchestra – 4 openings. Frank Cumberbach and Sadhna Lindvall are willing to be appointed. Symphony also asked us to keep one Co Supv, Luigi has been on it and it makes sense to reappoint him (OK per SKW). That still leaves one opening which would be a nice perk for someone who has been good to you. Mary Baker has been suggested and I will follow up with her.
- 5) Milw Co War Memorial Corp – one opening for a Co Supv – they have requested we appoint Ryan McQue, but he declined the appointment, Dave Drent will talk to the other supervisors on his board for recommendations and help in recruiting a supervisor.
- 6) MCFLS – need to appoint someone from Milwaukee City Library Board of Trustees – I asked Audra Brennen (Mayor Barretts office) to let us know if we should reappoint Ald D’Amato again, just to be fair to City of Milw.
- 7) Milwaukee Public Museum – one current opening, Sharon Cook is willing to serve and would like the appointment. Jim Villa was supposed to contact Jackie Schellinger about whether she wants to remain on the board, but I haven’t heard whether he called her. The museum folks would **really** like us to replace her. I think we should just replace her. Dasha said he would inquire with John Daniels’ whether his wife might be interested in the appointment if we don’t reappoint Jackie S.
- 8) Marcus Center – two openings, also good perks for someone who has been good to you. Ethnic diversity not an issue on this one. I have one possible appointee who would be a great fit – Tony Busalacchi who has really good credentials. Still need one more appointee candidate.
- 9) Personal Review Board – Robert Schroeder term to expire in Oct, I left him a message to call me and will ask him if willing to step down. Bob Dennik wants us to appoint Tom Nardelli, who asked for the appointment.
- 10) PIC Board – one opening that I am aware of. How about asking Larry Burazin, former Mayor of St Francis, who has asked Bob D to find him an appointment.
- 11) Lakefront Development Advisory Commission – you have four appointments
 - 1) Parks Director - Sue Black
 - 2) One citizen from business community – John Roethle
 - 3) Citizen – Bob Spindell
 - 4) Citizen – Ellen Brostrom, a lawyer from Reinhart Boerner, has good credentials, I spoke to her and feel that while she is definitely biased toward to preserving the public green space, that she does not have an activist agenda and would be fair.

- 12) Veterans Service Commission – We have two candidates to replace the two commissioners that we are not going to reappoint. Antonio Guajardo and Rev. Carl Krueger. Scott has mentioned the possibility of appointing the two retiring commissioners as Honorary Emeritus Commissioners – we are awaiting word from Corp Counsel about whether this can be done. There are other reason why this may not be a good idea, which can be discussed in person.
- 13) Milwaukee Homeless Continuum of Care Steering Committee (COC) – Joe Volk has requested that the Exec appoint a member of DHHS staff to this committee. I will pass the request along to Rob for recommendation of an appropriate staffer.
