

**Board & Commission Appointments**  
**Reappointments and Openings for possibly May Board Cycle action**

- 1) **GMCVB** – need to replace Shelia Aldrich with another Co Supv for 4 yr term.
- 2) **Public Art Committee** – 2 openings (Matthews and Murphy resigned) – indefinite terms
- 3) **Milwaukee Public Museum** – 1 opening (Jerry Gonzales resigned), 3 yr terms, museum would like someone who can raise money. Also SKW needs to talk to Jackie Schellinger about her level of commitment (possible opening).
- 4) **Milwaukee Symphony Orchestra** – 1 opening and 3 terms expiring 5/18/04 (Shelia Aldrich, Luigi Schmit & John Weishan) – term is up to exec. Appointees not required to be Co Supv, Exec may appoint anyone.
- 5) **MCFLS** – Michael D’Amato term expired on 12/31/03 – may reappoint or replace with another member of Milwaukee Public Library Board of Trustees. We should consult w/ ICC.
- 6) **Milwaukee Public Library Board of Trustees** – 1 opening – must be a Co Supv who does not live in city of Milw. 4 yr term.
- 7) **Civil Service Commission** – Roy Williams will resign when we have a new appointee ready.
- 8) **Ethics Board** – Mary Glass term expired 2/28/04, she expressed desire to be reappointed, John Carter has expressed desire to have her replaced. SKW needs to make decision whether to reappoint or replace.
- 9) **Marcus Center for the Performing Arts** – 2 terms expiring: David Espinosa 4/1/04 & John Finnerty 6/1/04. SKW needs to decide whether to reappoint or replace. 3 yr terms.
- 10) **Milwaukee County Historical Society Board** – 1 opening – term coincides with Exec’s term.
- 11) **PIC Board** – Nancy Olson resigned – 1 opening – 3 yr term.
- 12) **Aging Commission**: - one opening per Stephanie and two commissioners needing reappointment or replacement. 3 year terms. SSS wants the two commissioner reappointed and has a recommendation for the opening. I want to discuss this opening w/SKW before committing to SSS for her recommendation.
- 13) **EMS Council** – Supv Mark Borkowski’s term expired, also both mayors terms expired and all three must be reappointed or

replaced, (these terms coincide with elected office terms). Mayor Glowacki of Cudhay did not run for reelection and must be replaced. SKW needs to make decision about Borkowski.

- 14) **Personnel Review Board** – 5 year term. Robert Schroeder term expiring 10/31/04 – he does not wish to be reappointed (per Susan Shields, board staff).
- 15) **Veterans Service Commision** – 3 year terms. All three commissioners terms have expired. Recommend that all three be replaced with new appointees. Domingo to provide candidate names to chose from.
